

## THE 2018 MARTI FOUNDATION SCHOLARSHIP

General instructions - Either type your application or print with black ink. Do **not** use two-sided printing.

Regular application deadline - Applications for renewable scholarships that will start in Fall 2018 must be received at our office no later than 3 p.m. (local time), April 23, 2018, or if mailed, postmarked no later than Monday, April 23, 2018. **Note that this is much earlier than in previous years.**

One-time “pick-up” application deadline - Applications for a one-time (non-renewable) Spring 2018 scholarship must be received at our office no later than 3 p.m. (local time), Wednesday, December 20, 2017. (Students who currently have at least one semester remaining on a Marti Foundation scholarship should **not** apply for this “pick-up” scholarship.)

### Attachments

Attach copies of these documents to your application before you turn it in to us:

1. Completed budget form (the “STUDENT BUDGET FOR TWO SEMESTERS” page).
2. Your high school transcript.
3. Transcript from each college and/or technical school you have attended. (Include the transcript for any dual credit courses you took.)
4. List of the advanced placement courses you have taken, and indicate for each course whether or not you took the test.
5. Acceptance letter (on letterhead that shows the name, address, and phone number of the institution) from the college or technical school that you will attend.
6. Your FAFSA Student Aid Report (SAR) from the U. S. Department of Education. (Please black out any SSNs.)
7. If you were (or will be) claimed as a dependent on any person’s federal income tax return, the first two pages of his, her, or their IRS Form[s] 1040 (or equivalent federal tax form[s]) for last year. (Please black out SSNs and bank account information.) For most new high school graduates, this means the parent(s) with whom you live.

### Setting up your interview

Once your application is in our office, it is **your** responsibility to get in touch with us in person or by telephone (817/556-4687) during our office hours to make an appointment for your interview. We are normally open 9 a.m. – 3 p.m. on Monday – Thursday.

### Early interviews

Applicants who may not be able to schedule interviews with us in our office during our regular interview period should take advantage of our early interview dates:

Afternoon of Monday, April 30, 2018, starting at 4 p.m.

Afternoon of Tuesday, May 8, 2018, starting at 4 p.m.

### Regular interview dates

Regular interviews will begin on Monday, June 4, 2018. We plan to conduct interviews during the mornings on Mondays, Tuesdays, Wednesdays, and Fridays, and probably for a few hours on Saturdays. We hope to finish interviews by Saturday, June 23, 2018.

## ABOUT YOUR APPLICATION FORM

The Marti Foundation expects you to spend some time and effort to find the information you need to complete our application and budget forms.

We expect you to file the FAFSA (Free Application for Federal Student Aid) to get the U.S. Dept. of Education SAR. (However, unlike some other scholarship organizations, we do not require that you qualify for a Pell grant.) If there is any reason that you cannot file for FAFSA, please let us know as soon as possible; please do not wait until your interview.

For the student budget form, you should be able to get estimates for many of the items from your school's website.

If you, either of your parents, or your spouse is (or was) a military veteran, look into the Hazlewood Exemption before you apply to us.

We invite students who have attended Hill College and are ready to go on to their four-year colleges to apply to us. However, students who plan to attend Hill College this year and/or next spring need to apply to Hill College itself (through its website) or to other local scholarship organizations.

## ABOUT ACADEMIC SUCCESS IN COLLEGE

College instructors expect their students to put in a great deal of work outside the classroom -- as well as to attend every class, participate in discussions, take good notes, put effort into assignments (and turn them in on time), and be well prepared and thinking clearly for exams. For every hour spent in class, most instructors expect students to spend two to three hours outside of class studying, doing homework, preparing projects and reports, *etc.* **This is a tremendous change from most high school courses, even dual credit courses.** Learning everything that is presented in class is necessary, but it is not enough!

We consider an undergraduate student who completes at least fourteen academic hours per semester to be a full-time student because, if the student is doing it properly, it is at least a 50 to 60 hour per week job. (We encourage students to limit outside employment to 20 hours per week.) If you plan to ever take fewer than 14 hours, let us know in advance.

Make friends in class who will take notes for you in case you have to miss a class. Your instructor may be the one person in the classroom who isn't taking notes.

The Marti Foundation is a non-profit corporation organized exclusively for charitable and educational purposes and is described in IRC Sec. 501(c)(3). Our scholarships are for college and technical school students who are from Johnson County, Texas. The schools our students attend must meet the standards of applicable U.S. Treasury regulations as well as of our Board of Trustees; in general, the schools our students attend will be regionally accredited, non-profit institutions.

The Foundation generally expects each undergraduate student who receives a scholarship to complete at least fourteen academic hours towards his or her degree and to earn a grade point average of at least 2.75 every semester. Each student whose school considers him or her to be a full-time student in a particular semester even if he or she does not complete fourteen academic hours should discuss this with us before accepting a scholarship grant for that semester.

Each student who receives a scholarship for any semester must report to the Foundation **within thirty days after the end of that semester** (whether or not the student expects to receive another check) in order to turn in grades and our Student Semester Report. *United States Treasury regulations require these reports. They are extremely important. Even students who graduate, students who have used up the last semester of their original grants, and students who feel they don't qualify for continued assistance must turn in their grades and report how they spent our award for that semester.* We may also require scholarship recipients to visit our offices for conferences from time to time.

Our awards can only be spent for certain educational expenses (such as tuition and fees required for the recipient to enroll in and attend an accredited institution as a degree candidate, and fees, books, supplies, and equipment required for courses of instruction). We also ask for estimates of other expenses because that information helps us assess applicants' financial needs.

**Schedule your appointment for your interview by telephone, or in person when you turn in your application.**

Marti Foundation scholarship awards are based on factors that include financial need, not only on academic merit. If you do not receive a scholarship, please do not feel that this reflects badly on you in any way.
